Two Kurdish citizens has been sentenced 6 months in prison because of their musical activities

The Kurdish human rights organization in Syria (DAD) declared that the military court Judge in Qameshli sentenced, Sunday in 01/11/2009, two Kurds for six months in prison and pay one hundred Syrian pound as a penalty, and they are: Muhammad Saifeldin Alikhddo born in

Durbassiya 1986, and Nader Nawaf Khalil born in Durbassiya 1981, when they were accused for joining a forbidden secret association and inciting sectarianism. The two Kurds (Muhammad Saifeldin Alikhddo and Nader Nawaf Khalil) have been arrested before in 13/10/2008 by a military security patrol, because of their general activities especially in Kurdish folklore music but they have been released in 13/4/2009.

Five Kurdish Syrian political arrestees have been sentenced for 12 years

Supreme State security court in Damascus sentenced in its case in 03/11/2009 five Kurdish political activists, prison sentences ranging between seven and twelve years, their names are: Gagar Shikhmos his father is Muhammad Akram born in 1989, arrested in 15/01/2007. Safeqan Rashid Khello born in 1990 arrested in 19/02/2006.

The two kurds above mentioned have been sentenced for five years in prison, they were accused for joining forbidden political party (PYD) and trying to separate a part of the Syrian territory and to incorporate it a foreign country, and also sentenced for ten years imprisonment with hard labor in charge of actions to provoke a civil war, and comparing penalties and implementing the longest, ten years imprisonment with hard labor.

Ferhad Muhammad Muhammad arrested in 29/11/2006, sentenced ten years in prison after he has been accused for joining forbidden political party (PYD) and trying to separate a part of the Syrian territory and to incorporate it a foreign country.

Reshid Khello Khello born in 1988, arrested in 19/02/2006, sentenced seven years and a half, after he has been accused for joining forbidden political party (PYD) and trying to separate a part of the Syrian territory and to incorporate it a foreign country.

Shekri Khaled Omer arrested in 09/02/2006, sentenced five years after he has been accused for joining forbidden political party (PYD) and trying to separate a part of the Syrian territory and to incorporate it a foreign country, and for action to provoke civil war, and sentenced prison with hard labor for life, and because of mitigating reasons became twelve years and comparing penalties and implementing the longest, twelve years imprisonment.

The same court also sentenced in 8/11/2009 six years on four other arrestees from same Party PYD and they are:

Naser Ahmad Muhammad born in 1987, he is student at the Institute of Medicine - Department of Radiology 2nd year, arrested by political security in Damascus.

Raaed Fawaz Ali arrested in 19/07/2008.

Saoud Shikhmos Ibrahim arrested in 25/01/2009.

Abdelrahman Mustafa Muhammad born in 1974, arrested in 26/11/2008.

Crimes Court sentenced three years in prison on three leading Kurds

Crimes Court in Damascus sentenced on Sunday case in 15/11/2009 three years in prison on each of: Mustafa Jumaa Beker and Muhammad Saied Hussein Alomer and Saadon Mahmoud Shikho, when they have been accused of weakening national feeling and inciting sectarianism. The court also sentenced to deny their citizenship and refused the mitigating reasons and refused to reduce the sentences.

Arrest of Mohammed Saleh Khalil the leader in the Kurdish Democratic Party in Syria – PART I

the Kurdish human rights and public freedoms organization in Syria declared that a military security patrol in Afrin city in 11/11/2009 arrested Mr. Muhammad Saleh Khalil a member of Political Bureau of Kurdish Democratic Party in Syria because of his political activity without a warrant or sentence by judicial authorities.

The Kurdish leader Muhammad Saleh Khalil born in 1953, married, father of four children.

Security patrol arrested the Kurdish student Rojhat Muhammad Muhammad

According to the human rights and public freedom Committees in Syria, and according to legal Syrian sources, a security patrol in Almalikia city in province of Hassaka arrested the student Rojhat Muhammad Muhammad in 22/10/2009 and took him to the military security department of Hassaka.

Political Security in Aleppo arrested two Kurdish students

The political security in the city of Kobani called in 30/10/2009 two Kurdish students: Annter

Shawkat born in 1990, a student at the Faculty of Fine Arts 1st year at the University of Aleppo, and Mustafa Nassan, a student at the University of Beirut, and the both has been transferred immediately to the Political Security department in Aleppo.

German police arrest Anwar Dakouri member of the Human Rights Organization MAF

The human rights organization in Syria - MAF declared that German police arrested the organization member journalist Anwar Dakouri in 21/10/2009, in respond of the request of the French refugee Center because he apply for asylum in France in 2008, and while he was waiting for a court trail, that court released him in condition to ensure attendance on the court that would established by the French investigating Judge.

He was sentenced for a year, and banned from entering French territory for life. Then he returned to Germany, because he applied for Asylum in Germany too, but the German authorities refused to grant him asylum and residence permits, because of the request of the French refugee Center, due to request for asylum there.

In 12/11/2009 the Department of foreigners in the cities of Aachen and Halle requested to deport him by the German police, despite the presence of a decision from the Supreme Court of the Province of Saxony-Anhalt to accept the appeal that filed by his lawyer to the court, and the court accepted to reconsider the arrestment and deportation to France on Monday in 16.11.2009

Enforced disappearance of another Kurdish citizen in Syria

According to the Human Rights Organization in Syria MAF that Mr. Nashat Hannan Ben Mustafa, 45 years old, was arrested by the security patrol in Aleppo city in 27/10/2009, and transferred to the Political Security department in Damascus.

MAF said in a statement that Mr. Nashat Hanan had been subjected to discomforts and many questionings since the Feast of Newroz in 2008

Kurdish student has been fired from the University of Damascus and the university campus

Kurdish human rights and public freedoms organization in Syria DAD declared that the Vice President for students and administration issues of Damascus University issued a resolution no.515 in 05/10/2009 and it is: punishing a university student Pafel Ahmed Bin Ali, registered in the Faculty of Arts for the 2008 -2009, by firing him from UNI campus and firing him from the UNI for one year for breaking the domestic laws and regulations as stated In the resolution.

It is likely that this decision comes against the background of student activities Pafel Ahmed Ali in the media and press and especially the internet press, when military security patrol arrested him in Qameshli city in 05/04/2009 without a warrant and without a sentence from judicial authorities.

Then he was transferred to the military security department (Palestine Branch) in Damascus, till he has been released in 24/05/2009.

News about the possibility of arrest of the Kurdish writer and politician Pir Rustam

the human rights organization in Syria - MAF declared that they have news about the possibility of arresting the Kurdish writer and politicianl Pir Rustam after they received a message from the writer `s friends said that they couldn` t contact him and unusually they don` t know anything about his news while he was in Beirut. According to MAF The letter says: "that the security services of the Syrian regime arrested the Kurdish politician Pir Rustam (Ahmad Mustafa) Born in Afrin in1963, recently he lives in Beirut and Hewler. Till suddenly disappeared and the last contact with him was in 24/10/2009, and that what make, arresting him and transferring him to one of security department in Damascus, the most possibility The Kurdish writer and politician Pir Rustam is a member of: the Kurdish Human Rights organization DAD, and the National Council Of the Damascus Declaration, and a candidate member of the Central Committee of the Kurdish Democratic Party in Syria – parti, and he Has written fourteen books as Stories, studies and novels in Kurdish and Arabic.

Arrest of Ms. Yerevan Farouk Mohamed and Mr. Salim Aziz

According to the Kurdish human rights and public freedoms organization in Syria (DAD), the Syrian security authorities have arrested Ms. Yerevan Farouk Mohamed (the mother of an infant) and Mr. Salim Aziz, after calling them to questionings.

Ms. Yerevan Farouk Mohamed and Mr. Salim Aziz returned to Syria from Kurdistan of Iraq in 18/10/2009, where they have been arrested at Damascus International Airport for a while, and their passports have been seized and transferred to the Immigration Service and passports in Damascus, and then to the security authorities, and since that time they were always questioning by the security authorities and were exposed to various types of discomforts, according to Dad.
