#### Death of a Kurdish activist during his arrest

Human rights sources in Raqqa city declared that the body of Kurdish prisoner Hannan Abdelkader Mahmoud from Kobani region - Katie Cooley village is received by his family from the air intelligence department , and buried in his hometown on 06/28/2010. Hannan was a 27 year old, married, father of a child. He was arrested by an air security patrol on 15/05/2010, and his family did not know anything about him during his arrest until they knew that he died in prison.

## A Kurdish leadership member has been sentenced

The military court of Qameshli on 11.07.2010 sentenced to four months, Mr. Sulaiman Abdul Majeed Oso member of the Political Committee of the Kurdish Yekiti Party in Syria, with eight Kurdish citizens on charges of inciting sectarianism and racism, because of the Feast of Norouz celebrations in 2009. The group was arrested on the evening of 20.03.2009 by the security services patrol while they were trying to set up a platform for Zemin folk music group on Nowroz in Sad al Hassakeh region.

### Syrian security services arrested Kurdish political activists in response in different regions

The security forces arrested in July 2010 in Raqqa city six Kurdish citizens because of Newroz celebrations events this year in Raqqa.

And they are: Ibrahim Mamed Mahmoud, Mohammad Ayub Tammo, Mohammed Khalil Ayoub, Hajji Rachid Osman, Walid Rashid Osman, Masoud Rashid Osman. They were arrested by raiding their homes in the early morning hours and, as usual, without a judicial arrest warrant against them.

A political and a military security patrols in the city of Ain Al Arab - northern Syria arrested on 12/07/2010 the Democratic Union party member Attoun Arif Khalil, born in 1965.

The Political Security arrested in Aleppo the activist Hassan Sheikh Ahmed bin Ibrahim in July 2010 Ser sehor village in Ain Arab-kobani- region.

## Transfer of political Kurdish detainees to the military court in Aleppo

The Kurdish activist Manal Ibrahim Bint Ibrahim and the activist rojhat Mustafa bin Subhi were transferred to a military court in Aleppo, after they have been arrested on 15.10.2009 by the Political Security branch in Aleppo.
