#### A leadership member of the Kurdish Azadi Party has been sentenced

The individual military Judge in Qameshli city, on Sunday 06/20/2010 sentenced to a year the member of the Political Bureau of Azadi Party in Syria, Mahmoud Saffo, on charges of inciting sectarianism and racism and belonging to a illegal secret organization and being a leadership member in that organization.

A political security patrol in Malikia region – Al Hasaka province, arrested him on 28/03/2010.

#### The military court in Aleppo sentenced three Kurdish activists

The military court in Aleppo on 06/15/2010, sentenced for two and a half years to the Kurdish political detainees: Delshir Khatib Ahmed from Qameshli and Lawrence Hejer from Amuda city, on charges of belonging to a political organization that aims to separate a part of the Syrian territory and incorporate it a foreign country. The same court has also sentenced Fawaz Mehiuddin

from Amuda city for a year and three months in prison on charge of belonging to a political organization.

#### Kurdish recruits continue to be killed in mysterious circumstances

Several years ago the Kurdish recruits were killed during their military service in mysterious circumstances and nobody investigate nor disclose its details, and since the beginning of this year five recruits were killed:

- Nejm aldin Hassan Dalo born in Afrin - hekjah Village 1991, his body was handed over to his family on 06/07/2010. He was in Ain Issa battalion that stationed in the province of Raqqa .He had joined to the military service three months ago and his parents have informed that he had committed suicide during night shift gaurding.

- Hassan Muhammad Diro born in Zur Mugwer village - Ain al-Arab, 1981, his body was handed over to his family in 30.05.2010, he performed his military service in a military unit stationed in Hergeleh area - Damascus. He joined the service at the beginning of May and trained only 27 days until his death. His family has informed that he died because of heart attack, but his family disclosed the body and found that he had bruisings on his face and it was so clear on his lips as well as swelling in the head like he was beaten.

- Khabat Alliko born in Afrin 1991, his body was handed over to his family on 07.05.2010, he performed his military service in a border outposts in the area of Abu Kamal on the Syrian-Iraqi border.

According to his fellow soldiers who were with him during the exchange of fire, he was wounded in the left and right side of his chest and also in his hand, and he died because the wounds. the body had buried amid tight security measures and his parents were not allowed to disclose the body of their son, and did not able to verify the validity of claims about the cause and circumstances of their son's death.

- Mustafa Osman Busan born in the village and Qelich Wiran - Ain al-Arab 1989, died in mid-April 2010.

- Issa Bekki khalaf born in Ain Al Arab in 1991, his body was handed over to his family on 01/10/2010

#### A Kurdish student has been transferred to the military court

The Kurdish journalism student Radwan Rashid Osman has been transferred to the military court of Raqqa ,after he was arrested on 07.20.2010

He was born in Tel Abiad 1987, studies journalism at the University of Damascus.

# Arrest of Kurdish students from the University of Damascus because of their participation in a trip

Political Security arrested a number of Kurdish students at the University of Damascus because of their involvement in student recreational trip to the province Sweida on 04/09/2010. Those arrested include:

- Kaniwar Darwish: fourth year philosophy
- Therese Mirza: third year Philosophy.

#### Campaign of mass arrests of citizens in the Kurdish region of Ain Al Arab

The security services in the region of Ain Arab launched a campaign of arrests that impacted a number of Kurdish citizens in the region. In the month of April more than twenty citizens were

arrested, including:

Luqman Mustafa Na`asan , Khalil Osman Shekho , Jarrah Dawoud Shekho , Saleh Mohammed Busan, Muhammad Ali Hajj Afedo , Adel Khalil Krao , Ali Mustafa , Darwish, Abdul Qadir , Anwar Mesteh , Mohammed Issa, Juma Mohamed Issa , Iskandar Mohamad Issa , Masoum Mostafa Issa , Mohamed Ramadan Muslim , Ramadan Mohamed Muslim , Adnan Ramadan Muslim , Mohamed Mahmoud Muslim , Moustafa Mahmoud Muslim , Yakob Mahmud Muslim , Haji Ismail, Muhammad Ismail , siad Mahmud , Ismat Sheikh Hassan.

Also on 15.02.2010 Abdullah Mohammed Isso, a student at the Faculty of law in Egypt "the fourth year" was arrested.

Also on 03/05/2010 Buzan Buzan Abdul-Qader and Waheed Khalil Yousef were arrested.

#### Arrest of Kurdish refugee in Germany and intention to deport him to Syria

According to the family of the Kurdish refugee Farouk Al Issa, the German police arrested him on 21.06.2010 in the Department of Foreign Affairs in the city of Wilhelmshaven, when he revised the department to extend the temporary residence paper that he carried. And the police submitted him to the City Court, which issued a decision to arrest and placed in deportation prison in Langen Hagen near the city of Hanover.

He was informed that he will go on 18 or 20 August 2010 to Syria, and till then he will remain in prison.

Mr. Farouk Al Issa had taken refuge in 2004 to Germany, but his request for asylum was rejected.
