The military court in Qameshli sentenced the leadership member Hassan Saleh in Yekiti Party

The individual military Judge in Qameshli on Tuesday 16/02/2010 sentenced to one year and for the mitigating circumstances reduced the sentence to imprisonment for eight months to Hassan Saleh , a member of the Political Committee of the Kurdish Yekiti Party in Syria, on charges of belonging to a secret forbidden organization and inciting sectarianism and racism. The individual military judge issued at the same case an unjust sentence to imprisonment for six months for the mitigating circumstances reduced the sentence to four months on each of: Shahbaz Nazir Ismail, Siwar Abdul Rahman Darwish, due to their possession of publications belonging to Kurdish Yekiti Party in Syria.

Siwar Abdul Rahman Darwish was arrested on 20.12.2008 by the security patrol in Qameshli during a routine search for smuggled goods in his shop in Qameshli, where they found the publications of Yekiti Party. And then he has been transferred to the political security where he

admitted that he has received those publications from Shahbaz Nazir Ismail, who has Optics shop in Qameshli, to be arrested also and admitted that the publications are belonging to the leadership member of Yekiti Hassan Saleh, which approved it too.

Death of a detainee under torture in Aleppo central prison

The Syrian Committee for Human Rights in declared that the Syrian Kurdish citizen Mohammed Mestto Rashid from Afrin city died under torture in the Central Prison in Aleppo. He had been arrested about four months ago and has been subjected to severe torture and transported to Hemmiat Hospital in Aleppo, and after he had stayed for four days in the hospital he had returned to prison and there they announced his death on 19.01.2010

Sentenced Khaled Ma`mo Kengo to prison after deporting him from Germany

The Individual military Judge in Qameshli sentenced on Monday 02/08/2010, Khaled Mamo Kengo for four months in prison and a fine of eighty Syrian pounds, who has been deported from Germany to Syria earlier according to the agreement that has been signed between the two countries regarding the deportation of illegal immigrants.

State Security in Qameshli arrested citizens arbitrarily

The State Security Patrol in Qamishli arrested on 18.02.2010:

Montaser Ahmed Khalaf, who works as a party's photographer and owns computer store in Amuda town, and Alan Ahmed Hussein, a florist store owner in Amuda, were arrested without a warrant and without specifying the reasons of detention.

The military justice in Qameshli sentenced four Kurdish citizens to six months in prison. The Individual military judge in Qamishli sentenced each of: Ali Mohammad Ma`soom Ma`mo, Salar Hussain Ahmed, Mohammed Nawaf al-Mohammad and Bangin Sheikh Musa Shikhamos imprisonment for six months and one hundred Syrian pounds as a fine for inciting sectarian strife.
