Arrest the kurdish religious well known Sheikh Abdul Razzaq Ginco

Air Intelligence services in Aleppo International Airport on 01.01.2010 arrested the Kurdish religious Sheikh Abdul Razak Ginco, on his way to the United Arab Emirates. Sheikh Abdul-Razzaq Ginco, born in Qameshli city in 1948, Holds a Bachelor of Islamic law from Damascus University, worked as a teacher in the schools of Qameshli for many years and also worked in United Arab Emirate Schools before returning to Syria for retirement.

Kurdish recruit Issa Bekkie khalaf death

The recruit Issa Bekkie Khalaf 's family received their son`s body on 10.01.2010, and they were informed that he committed suicide by shooting himself. He was form residents of Ain al-Arab and born in 1991, and was serving in Fifteenth military command that stationed in Daraa.

A human rights organizations declared that a few days earlier he complained to his family, before they received the news of his death, about hard treatment and tough physical punishments that he has to do by the responsible officers orders.

It should be mentioned that similar cases of Kurdish conscripts deaths have repeated especially in the last two years, and it is always said "suicides" without revealed the circumstances or the results of investigations that carried out.

Block the website of the Kurdish Future Current

According to the Kurdish Future movement that their website has been blocked and they accuse the Syrian security forces. It should be noted that most of the Kurdish websites are blocked in Syria, as well as a lot of other websites, especially that who are close to the Opposition and that criticize the regime.

Kurdish detainees has been sentenced on charge of inciting sectarian strife

The military Judge in Qameshli city on 01/17/2010 sentenced a number of Kurdish detainees of conscience and they are: Abdul Salam Sheikhmos Mahmoud and Khalil Ibrahim Mohamed and Mohamed Sheikho Issa and Rami Sheikhmos Hassan as follows:

- Sentenced Abdul Salam Sheikhmos Mahmoud and Khalil Ibrahim Mohamed and Mohamed Sheikho Issa and Rami Sheikhmos Hassan for six months in prison on charge of inciting sectarian strife.
- Sentenced Abdul Salam Sheikhmos Mahmoud and Rami Sheikhmos Hassan for a month in prison and pay a hundred Syrian pounds on charge of raising riot.
- Merge the two penalties for Abdul Salam Sheikhmos Mahmoud and Rami Sheikhmos Hassan and only took the longest punishment and that is six months in prison.
- Reducing the penalty of imprisonment for each of Khalil Ibrahim Mohamed and Mohamed Sheikho Issa to three months in prison , and each of Abdul Salam Sheikhmos Mahmoud and Rami Sheikhmos Hassan to three months and a half in prison.

The four detainees were arrested in March 2009 on the background of standing in memory of the victims of the Helabja massacre 1988 and released in April 2009.
