Arresting the Kurdish writer Siamend Ibrahim

After several calls to the security department, the military judge in Qameshli on 11/29/2010 decided to arrest the Kurdish writer Siamend Ibrahim and transfer his case to the Military Public prosecutor of Aleppo, on charges of inciting racism and conflict between communities and members of the nation.

Military Court in Aleppo sentenced the lawyer Mustafa Ismail and other citizens

Military Court in Aleppo on 07/11/2010 sentenced for two years and a half the lawyer and human rights activist Mustafa Ismail, born in 1973, who was arrested by Air force Intelligence Branch in Aleppo on 12/12/2010 because of his writings on various websites and his participating in talks

with some Kurdish satellite channels. In addition to his work in the legal profession, he is a writer and poet as well.

The Military Court in Aleppo also sentenced on 29/11/2010 Delshir Khatib Ahmed from Qameshli city and Lawrence Hajer from Amuda city for a year and a half on charges of doing actions and writings that disturb the relationship with a foreign country.

The same court sentenced in the same case and the same charges Fawaz Mehiuddin Hassan from Amuda city for one year. It is noteworthy that Mr. Fawaz Mehiuddin Hassan had been released earlier and stayed in prison longer than the sentence period.

Military judge in Qameshli city jailed four Kurdish citizens

Military Judge in Qameshli on 09.11.2010 decided to imprisonment for one month, on charge of participating in rallies riot in protest against the decisions of the Authority, each of: Luqman Ibrahim Hussein, born 1968, and Salah Mohammed Said Younis, born 1968, and Abdul Ghafoor, Hussein Hussein, born 1956, and Saad Ferman Alhassan, born 1972.

It is noteworthy that these four people had been arrested on charges of responding the invitation of several Kurdish parties on 10.09.2010 to stand five minutes of silence to protest the decree No. 49 of 2008 and the passage of two years on the issue and its applications.

Also the military judge in Qameshli sentenced on the same date Mr. Muslim Hussein Abbas, born 1974, for four months on charge of inciting racism. The sentenced has been arrested on 12/09/2010 by a patrol belonging to the political security in Hasakah.

Syrian security authorities arrested a citizen after deporting him from Turkey

Syrian security authorities arrested Mr. Serbast Mohammed Rashad Abbou after deporting him from Turkey, where he had traveled to illegally in order to transit to Europe. The detained remained under arrest there about thirteen days before being deported to Syria, where he was detained and referred to the military prosecutor in Hasakah on 10/21/2010. It is noteworthy that Mr. Serbast Mohammed Rashad Abbou, born in 1986, a graduate of the Agricultural Institute.

Arresting the student Rasheed Khalil

A security patrol in Afrin city on 02/09/2010 arrested the student Khalil Rasheed bin Khalil,born 1989, a second year student at the Health Institute in Aleppo, the student was arrested without knowing the reasons or the place of detention.

A State Security patrol raided a house in Qameshli and arrested a citizen

A State Security patrol in Qameshli city, mid-November 2010, raided the house of Mr. Yussef Amad Merjan in the city of Kahtaniya - Hasakah province, inspected and checked the house and seized his PC without a warrant or court order and without knowing the reasons. His fate is still unknown as the circumstances of his detaining.

A security patrol raided the house of Mustafa Sheikho and arrested him and his brother

A Security patrol raided the house of Mr. Mustapha Sheikho on 09.11.2010 in Sheikh Alhadid town in Afrin region and arrested him with his brother.

Their father Mohamed Waheed Sheikho, 56 years old, has been beaten and insulted by the patrol during the raid.

A Political Security patrol in Damascus raided a house and arrested a citizen

A patrol belonging to the political security in Damascus on 11/3/2010 to raided the house of Mr. Farhan Haji selo and arrested him and seized his personal stuffs and a laptop.

It is noteworthy that Mr. Farhan Haji selo, born in 1977, from Malikia - Hasakah province, live and work in Damascus.

A Call to reveal the fate of Mr. Ayed Mohamed Osman

The family of the citizen Ayed Mohamed Osman said that he is absent since 02/11/2010, and there is no news about his place and the reasons for his disappearance or his arrest.

It is noteworthy that Mr. Ayyad, Mohamed Osman, born in 1974 from Ain Arab-Kobani-, and a resident of Ras Alein city - Al Hasakah province, a member of the Syrian Communist Party and well-known union activist in his region.
