### **Military Court in Aleppo sentenced a citizen because of her writings**

Military Court in Aleppo on 26/10/2010 sentenced to two years on the citizen Ms. Manal Ibrahim Ibrahim on charges of doing actions and writings that disturb the relationship with a foreign country. The citizen is a Kurdish, born in Hasaka 1981 and arrested in Aleppo city on 15/10/2009.

### **Military judge in Qameshli sentenced to six months Mr. Hozan Hassan Mohamed**

Military Judge in Qameshli on 03.10.2010 sentenced to six months Mr. Hozan Hassan Mohammed, on charge of doing actions that inciting racism. Mr. Hozan Hassan Mohamed, born in Qameshli 1986, was arrested by the security services on 6/15/2010 for unknown reasons.

### **Another Kurdish conscript has been killed in mysterious circumstances**

The family of the Kurdish conscript Mahmoud Shikho received his body on 10.9.2010, he was

served in a military unit in the province of Latakia, was buried in the village of Tel Hasel in Alsefira region in the province of Aleppo. The military authorities told his family that he committed suicide without mentioning any details. It said that there were bullet wounds on his body.

#### **Arrests:**

#### **A Citizen has been arrested on the border coming from Turkey**

The Syrian security forces arrested the young man Shiraz Sabri Nebo on 9/26/2010 while he entered Syrian territory from Turkey, without knowing the reasons of the detention or his location. His father and his brother were arrested too on the background of NEWROZ events in Raqqa city this year 2010 and they are still detained.

#### **Political security arrested several citizens in the regions of Ras al-Ain and Derbassiyeh**

The Political Security branch in Hasakah arrested six citizens from a village in Ras al-Ain region on 17.10.2010, and they are:

Saud al-Haj Khalil Mamdouh ,born in 1972, Nawaf Ahmed Farhan , born in 1948, Shukri Hussein Khalil Farhan,born in 1966, Abdel Rahim Mahmoud Farhan, born in 1977, Farhan Antar Al-Mohammad ,born in 1959 and Kameran Mohammed Sediq Farhan ,born in 1971, on charges of paying a voluntary financial contributions to the PKK.

Also a political security patrol in Derbassiyeh on 14/10/2010 arrested the brothers Sheikmous Muhammad Ali bin Muhammad and Ali Muhammad Ali ibn Muhammad from the village of Alghannamia in Derbassiyeh region.

The Political Security in Derbassiyeh on 15.10.2010 arrested Mr. Muhammad Ashraf Musa Rammo, born in 1955, and he is deprived of Syrian citizenship. And also the same authority arrested in the same period the citizen Mohamed Ahmed Oskan born in 1960.

On 16/10/2010 Ms. Zozan Mohammed Shikho, born in 1987, has been arrested from her place of work at the Salon of haircut for ladies in the city of Ras al-Ain and referred to the military judge in Qamishli on charges of inciting sectarian strife.

On the same day the two citizens Abd al-Rezzaq Suleiman Sino, born in 1979, and Ibrahim Kheder Hussein have been arrested in the city of Ras al-Ain.

#### **Security services in Malikia city arrested three citizens**

The state security patrol in Malikia city on 10/26/2010 arrested Mohammed Sadeq Mulla Hussain, known as "Kori", and on the same day a military security patrol in Malikia arrested Hassan Obeid bahram.

And on 10/28/2010 a political security patrol in Malikia arrested the citizen Solieman Jawish , the reason of the detention of them is still unknown.

#### **Syrian security services arrested citizens that have been deported from Cyprus**

Syrian security services arrested three Kurdish citizens that have been deported from Cyprus to Syria, and they are:

Rakan Elias Junbuli, Hassan Elias Junbuli and Mohamed Shefa Junbuli who the Cypriot authorities allowed his wife to stay in Cyprus because her baby was born there and Acquired Cypriot citizenship by birth.
