Raids and arrests

Since the beginning of the protests, the security forces has confronted it with violence, and dispersing it brutally, using live ammunition, which caused the death of 2'000 persons at least, while a bigger number were injured, and 15 thousands were detained as a result of the protests spread all over Syria since half of march.

Kurdish youths are taking part in the protests as well, and facing the same violence the rest of the Syrian.

Through July many were arrested:

- Assad Hindo Fattah, arrested on Sunday 24-07-2011 by the security forces, an owner of a patisserie in Qamishly, nor the place he was taken to neither detention conditions are known
- Sipan Hussein Osse, arrested in 29-07-2011 in a street in Qamishly, transferred to a security department in Aleppo
- -Hamid Saadeldin Jol Beg, born 1959, Kobane- Ain al Arab, arrested in 05-07-2011 from his work place in finance office of Ain al Arab, after he was requested by the airforce security branch in Aleppo
- Weis Othman Shexi, known by Weis Osse, arrested by the air force security in Aleppo on Tuesday 19-07-2011, he is a party cadre in the Kurdish Yekiti Party in Syria, he was previously

arrested by the same branch two and a half months ago in charge of participating in the protests being held in Ain-Arab

- Shoresh Jamal, a femal student in Euphrates University in Deir Ezzor, arrested in 09-07-2011, she is a Qmishly resident
- Nawal Shahin, arrested in July 2011, in Damascus, Qeimarieh.

The security forces has performed a vast wave of raids in Hasakeh city and arrested some men from their homes in 16-07-2011 in many neighborhoods of the city, because of their participation in the protests of the "freedom for detainees" Friday in 15-07-2011 which have took place in Ghweran and Mufti, and affected Suleiman Hmadi Mahel, Abdul Azziz Khalaf Al khidir, and Basil Khalil Al Kidir
